

Schibsted ASA (SCHA/SCHB) - Repurchase of own shares

Please see below information about transactions made under the buyback programme announced on 9 September 2024.

Date on which the repurchase programme was announced: 9 September 2024

The duration of the repurchase programme: The buyback programme is planned to be finalised within 2 May 2025.

Size of the repurchase programme: The purchases will be split 50/50 in nominal terms between A and B shares, buying up to NOK 1 billion for each of the share classes.

For the period 21 until 27 January 2025, Schibsted has purchased a total of 197,152 own A-shares at an average price of NOK 338.0459 per share, and a total of 205,889 own B-shares at an average price of NOK 322.0440 per share.

Following the transactions above, Schibsted has bought back a total of 4,178,370 shares with a transaction value of approx. NOK 1,411,128,572 under the buyback programme.

The issuer's holding of own shares:

Following the completion of the above transactions, Schibsted owns a total of 2,025,484 own A-shares, and a total of 2,536,540 own B-shares, corresponding to 1.95% of total issued shares in Schibsted.
